Many countries and states have requirements about product content (i.e. RoHS, IEC62474, REACH, Hong Kong Convention, etc.), or related as i.e. the Dodd-Frank-Act on Conflict Minerals. Whenever reports have to be made, there is a large and expensive effort to collect and report on data that is distributed throughout an extensive supply chain. Keeping the process of collecting, storing and analyzing this data efficient while controlling costs is a major challenge for manufacturers of products. Distributing data responsibility throughout the supply chain helps to keep your risks in meeting international regulatory requirements as low as possible. Solution Description

HPE CDX is a centrally operated and supported service that allows for standardized creation and exchange of Material Data Sheets (product structures, MDS), as well as CMDs (Conflict Minerals Declarations) throughout the supply chain by using our sophisticated Conflict Minerals Declaration Manager, thus supporting the establishment of material management processes. The service consists of a central database, a software application and user interface to make use of the data, as well as a substance service that ensures only valid data forms that basis of your MDSs, a material service that provides data for materials manufactured to a public standard, a service centre and training through our partners. As the core of the service is web based, no investment in additional software is necessary.

Though the main functionality and data structures are standardized for all industries and data may be communicated through all participating supply chains, the system is modularized, so that requirements of specific supply chains are easy to adapt regarding

- Data requirements
- Industry specific validation and processes
- Industry specific reporting
